Attached please find a form for a Certificate of Revival of Charter for a forfeited corporation to be filed in accordance with Section 312 of the General Corporation Law of the State of Delaware. The fee to file the Certificate is \$189.00. If the document is more than 1 page, please include \$9.00 for each additional page. You will receive a stamped “Filed” copy of the submitted document. A certified copy may be requested for an additional \$50. Expedited services are available. Please contact our office concerning these fees or you may consult our fee chart at [corp.delaware.gov](http://corp.delaware.gov). Checks should be made payable to “Delaware Secretary of State”.

Before the Certificate can be filed, all taxes due to the State at the time the corporation became forfeited must be paid and all applicable Annual Franchise Tax Reports must be filed. The Annual Franchise Tax Reports and Franchise Taxes must be filed and paid online at [corp.delaware.gov](http://corp.delaware.gov). Please contact the Franchise Tax Section with any questions.

For the convenience of processing your order in a timely manner, please include a cover letter with your name, address and telephone/fax number to enable us to contact you if necessary. Please make sure you thoroughly complete all information requested on this form. It is important that the execution be legible, we request that you print or type the name of the person signing under the signature line.

## Special Instructions – Revival for Forfeiture

- 1. The current name of the corporation exactly as it appears in our records. Please visit our website to verify the name and to check for name availability. If the corporation was originally incorporated under a different name, the original name of the corporation must be included in Article 1.*
- 2. List the complete name and address, including county, of the Delaware registered agent you are appointing to accept service of process for the corporation.*
- 3. List the date the corporation filed their Certificate of Incorporation with the Delaware Secretary of State.*
- 4. Statement required by Section 312(d)(3); no action needed.*
- 5. The actual day the corporation was forfeited for failure to obtain a registered agent.*

**Execution Block** - *The document must be signed by an authorized officer of the corporation pursuant to Section 103 of Title 8. The name of the person must be typed or written legibly underneath the signature.*
