The fee to file the Certificate is \$5.00. You will receive a stamped “Filed” copy of your submitted document. A certified copy may be requested for an additional \$50. Expedited services are available. Please contact our office concerning these fees or you may consult our fee chart at www.corp.delaware.gov.

Before the Certificate can be filed, all applicable Annual Franchise Tax Reports must be filed. Please contact the Franchise Tax Section prior to submitting the document for filing to determine the Annual Reports due. Please make your checks payable to “Delaware Secretary of State”. You may submit the required Annual Franchise Tax Reports along with the Renewal and you may include all filing fees and Annual Franchise Tax Report fees due in one check.

For the convenience of processing your order in a timely manner, please include a cover letter with your name, address and telephone/fax number to enable us to contact you if necessary. Please make sure you thoroughly complete all information requested on this form. It is important that the execution be legible, we request that you print or type the name of the person signing under the signature line.

Special Instructions – Renewal for Void Exempt Corporation

This form is to be used as a Template only. The following instructions will help you in correctly completing your Renewal Certificate. The instructions will be numbered to correspond with the article it is referencing.

- 1. The current name of the corporation exactly as it appears in our records. Please visit our website to verify the name and to check for name availability.*
- 2. List the complete name and address, including county, of the Delaware registered agent you are appointing to accept service of process for the corporation.*
- 3. The date when the corporation was originally formed.*
- 4. A statement that the renewal is to be perpetual or if not perpetual you may draft a document stating the time for which the renewal is to continue.*
- 5. The actual day the corporation was Voided for failure to file a complete Annual Franchise Tax Report.*

Execution Block - *The document must be signed by an authorized officer of the corporation pursuant to Section 103 of Title 8. The name of the person must be typed or written legibly underneath the signature.*
